4. Please provide, with your schedule, the address of the financial aid office of the institution that you will be attending
5. The scholarship awarded must be claimed by March 26<sup>th</sup>, 2027
6. You must be enrolled for the 2026 -2027 academic year and distribution.

You may apply for a one time extension. You must do so in writing before March 26<sup>th</sup>, 2027. The letter must be addressed to the Canyon County Regional REALTORS® Foundation in care of the Board of Directors. You must explain the reason(s) for the extension. The decision to extend the scholarship will be at the sole discretion of the Canyon County Regional Foundation Board of Directors and will be reviewed on a case by case basis.
